RESOLUTION NO. 97 S. 2013

APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGETS FOR
CALENDAR YEAR 2013 OF DIFFERENT BARANGAYS INCLUDING SK BUDGETS

WHEREAS, a review of the Supplemental Budgets of different Barangays including SK Budgets shows substantial compliance with the provisions of the Local Government Code of 1991.


